# **INSTALLATION TIPS**

Choose a mounting location suitable to support the full weight of the system when operating.

Make sure to properly lubricate o-ring prior to use.

Use 3/4" water line (optional reducer bushings included).

Install vertically with bowl hanging down.

Allow 2 1/2" (6.35 cm) clearance below the cartridge for easy cartridge replacement.

# **OPERATION TIPS**

Deliming of equipment prior to application is recommended, but not required.

Inspect SS-IMF cartridge at least every six (6) months.

Replace SS-IMF cartridge before Hydroblend™ compound is completely dissolved.

Pre-existing equipment scale may come loose and clog equipment. Remove any loose scale to assure satisfactory operation.


